2. The sale of ready-to-eat food or beverage items is prohibited
3. The Marketplace will include hand-crafted items and home-based businesses. Commercial merchandise must be approved by the coordinator and the North Iowa Band Festival Committee. No flea market/carnival-type items.
4. Exhibitors must be present and set up during all hours open to the public. No early tear-downs, unless pre-approved by the coordinator.
5. All canopies and display materials will be provided by the crafter. Table covers are required.
6. No tent stakes are allowed due to the underground water system in the park.
7. Spaces may not be subleased.
8. Electricity is not provided.
9. Dogs are not allowed in Central Park during the festival.
10. Parking spaces available Saturday & Sunday in Wells Fargo Bank of Iowa east lot, must display placard provided by Marketplace Coordinator.
11. Vendors must obtain a tax permit from the Iowa Department of Revenue before event.
12. **Cancellation refund deadline is May 1, 2017 - no exceptions.**
