# **NOTEWORTHY ACCOMPLISHMENTS 2019-2020**

Despite the obvious obstacles, the Chamber of Commerce made several noteworthy achievements in the past year.

- Hosted the first annual *State of North Iowa* event at the new multipurpose arena in January, recapping the importance of staying ontask with the *Vision North Iowa* strategic plan and hearing from Iowa Economic Development Director Debi Durham. Durham praised North Iowa for its many current initiatives and shared how the region can align with the state's "This is Iowa" marketing campaign.
- Continued to promote and enhance talent retention and attraction efforts through the Community Concierge program.
- Received "Chamber of the Year" honors from the Iowa Chamber of Commerce Executives (ICCE) organization—its highest award. ICCE noted the Chamber's superior service to the business community; contributions to place-making and economic development; maintaining sound fiscal policies and organizational management; and government advocacy efforts.
- Despite the pandemic, produced a long list of events including *Picture Day, Chamber Bowl, Ag Breakfast, Band Fest Spirit Week, Moonlight Bike Ride, CEO Conversations, Breaking Glass Women's Leadership Series, Golf Outing, and the inaugural Chamber Cup.*

Perhaps most importantly, the Chamber utilized its strong relationships and Emergency Response Plan to assist employers and employees in responding to the challenges of the COVID-19 Pandemic:

- Produced a dedicated page on the website with daily updates on pandemic resources and information from members regarding business hours, special offerings, etc.
- Sent *North Iowa Strong* emails as frequently as necessary with links and information to the most up-to-date resources for businesses and their employees.
- Connected members with new programs such as the Small Business Recovery & Continuity Grant program, Save Small Business grant program, and CARES Act programs through the SBA and other state and federal agencies.
- Produced and facilitated Facebook LIVE events to distribute information and provide access to local, state, and federal officials.
- Utilized membership in the Iowa Chamber Alliance and Iowa Chamber of Commerce Executives to gather best practices and share information.
- Actively worked with *Vision North Iowa* partners to coordinate COVID-19 response locally, including representation on the county Joint Information Center (JIC).
- Assisted members with marketing efforts to generate local business.
- · Organized and facilitated a virtual wellness seminar focusing on mental health aspects of the crisis.
- Staff made phone calls to the entire 650+ membership list to offer assistance.
- ...and this work continues.

# SMALL BUSINESS OF THE YEAR

## Northwestern Steakhouse

## Bill & Ann Papouchis

100 years. Now, that's staying power. In an industry where the average life span of a family-owned restaurant is less than four years, the Northwestern Steakhouse has been a Mason City staple for 100 years and counting.

The Papouchis family planned a blow-out celebration for the restaurant's BIG birthday in July, but when the pandemic hit, things changed. The steakhouse closed briefly under state government orders, but reopened for take-out orders as soon as it was possible. After all, the restaurant has already weathered Prohibition, the Great Depression, World War II, and the 1980s Farm Crisis since opening its doors in 1920.

In fact, when Anthony "Tony" Papouchis (and Pete Maduras) started the business near the cement plants on Mason City's north side, Tony had only lived in the United States for about five years and spoke limited English. He brought his cooking skills, which were honed in the Greek Army, and focused on simple recipes with high-quality ingredients. The business partners planted a garden behind the restaurant to supply fresh vegetables.

In 1965, Pete sold his share to Tony and the restaurant officially became the Northwestern Steakhouse. Tony's son, Bill, served as manager and took over as co-owner with his wife, Ann, when Tony passed away in 1991.

The business is the recipient of numerous awards, including being named "Most Iconic Steakhouse in Iowa." For many, eating at the restaurant is a family tradition for celebrating birthdays, anniversaries, holidays, and other special occasions.



Bill and Ann intentionally keep their restaurant small so they can maintain meaningful relationships with employees and customers. The restaurant attracts customers from all over the country, including the rich and famous, but the staff strives to treat everyone with the same great service and serve up the same great food (Greek steaks, freshly-baked bread, Greek salads, and that scrumptious, buttery spaghetti.)

He purchased gift cards from surrounding shops and presented them to customers who purchased bikes from Wayne's in an effort to support other businesses."

While Matt's generous action doesn't explain what makes him a great boss, it speaks loudly about his character...which is one of the attributes his employees love. Indeed, Matt has a holistic approach to his business. He's deeply invested in cycling for the physical and mental well-being of his customers, his staff, and himself. In fact, Matt loves nothing more than going on a morning bike ride with his co-workers before work. He provides facilities for the staff to shower, cook, and do laundry, which makes participating in outdoor activities adjacent to work time more accessible and enjoyable.

In addition to showing a genuine concern for his employees, Matt has a servant heart. He uses his time and resources to support SPIN Devo (junior bike racing team), North Iowa Human Powered Trails, Mohawk Mountain Bike Club, the Chamber's *Moonlight Bike Ride*, TRI Clear Lake, and the North Iowa Touring Club. He helps bring new visitors to North Iowa through his significant investment in the Bicycles, Blues & BBQ festival and the Cannonball CycloCross races.

Waldo Smeby has been named Mason City's *Distinguished Citizen* for 2020. Wally has been the driving force in numerous noteworthy community projects—usually from behind the scenes.

As a proud graduate of Luther College, Wally credits his first boss with teaching him the importance of getting involved in the community. In those early years, he was active in the JayCees and his church, and he continues to serve in civic roles.

As the founder of NIACC's Presidents Club, Wally brought together CEOs from across North Iowa to tackle tough business issues. He created a forum for sharing information and learning new industry trends that helped move the region forward.

## WORKPLACE WELLNESS AWARD Smithfield Foods & Assa Abloy - Curries

The *Workplace Wellness Award* reflects a partnership between the Chamber and CG Public Health, and the application process is extensive. Two Mason City manufacturers went above and beyond customary health and wellness standards during COVID-19. We are pleased to recognize Smithfield Foods and ASSA ABLOY-CURRIES for their efforts.

Smithfield Foods has free and unlimited COVID testing on-site daily for all employees. Management rearranged production lines to accommodate physical distancing and added physical barriers. The team distributed multiple bottles of hand sanitizer to each employee, and a sanitation mandate occurs every 30 minutes.

ASSA ABLOY-CURRIES workplace wellness program is operated by a committee comprised of workers. It focuses on employee engagement activities such as blood drives, group walks, and more. They offer an on-site ARNP Clinic in partnership with Iowa Specialty Hospital. During COVID-19, the company dispatched more than 120 employees to work remotely, provided PPE, and established social distancing throughout the facility.



## TREES FOR THE TOWN - FLOODING OUR COMMUNITY WITH FRUIT

The 2019-20 **YIELD** class planted fruit trees in Mason City's flood plain areas to help rejuvenate the land and provide fresh produce to community members. Their main focus was the area north of East Park and adjacent to Oak Park, which was badly impacted by the 2008 flood.

The **YIELD** group consulted with local nurseries, conservationists, city staff, and conducted research online to select fruit trees and other tree varieties that will work best in the flood plain areas. Students were responsible for securing all donations, and thanks to contributions from individuals and local businesses, they were able to purchase and plant more than 50 trees.


